

**MILLENNIUM CHALLENGE ACCOUNT - INDONESIA

Fiscal Agent Services**

The Republic of Indonesia ("**Indonesia**") has been declared eligible for a poverty reduction grant from the Millennium Challenge Corporation ("**MCC**"), a United States government agency. In connection therewith, the Government of the Republic of Indonesia (the "**Government**" or "**GOI**") submitted a proposal to MCC that resulted in a Compact signed on November 19, 2011, between the Government and MCC pursuant to which MCC committed to provide a five year, multimillion dollar poverty reduction grant to the Government of the Republic of Indonesia (a "**Compact**"). The Government intends to use a portion of the funds provided through the Compact to fund professional Fiscal Agent services from a firm/organization ("**Fiscal Agent**" or "**Consultant**") to assist the Government with the management of the Compact program in a transparent and fiscally sound manner, all in accordance with the terms and conditions set forth in a Fiscal Agent Agreement ("**Fiscal Agent Agreement**").

KEMENTERIAN NEGARA PERENCANAAN PEMBANGUNAN NASIONAL REPUBLIK INDONESIA/BAPPENAS RI, acting on behalf of the Government until the MCA-Indonesia is fully established, now invites proposals to provide Fiscal Agent services. More details on the agent services are provided in the Terms of Reference.

Moreover, Government-owned Enterprises (GOEs), as defined in Part 14 of MCC Program Procurement Guidelines, are not eligible to compete for MCC-funded contracts.
