- a. Have a business license as a provider of management consulting services (KBLI 7020)
- National business entity that has specifications for consulting services and has a Business Permit (SIUP)/Business Number-Indonesia Standard Industrial Classification (NIB- KBLI), Company Registration Certificate (TDP), and Articles of Association (AD/ ART);
- c. Have a business license in Indonesia and is domiciled in Indonesia;
- d. Have a Taxpayer Identification Number (NPWP) and Annual Tax Return (SPT) for thelast year (in 2020);
- e. Have experience:
 - Work in the field of Consulting Services at least 1 (one) job within the last 1 (one)year in the government or private sector, including subcontracting experience;
 - Similar jobs based on the type of work, complexity of work, methodology, technology, or other characteristics that can describe similarities, at least 1 (one) jobwithin the last 3 (three) years both in the government and private sector, including proven subcontracting experience with proof of contract/reference from the user accompanied by the value of the work;
 - The highest value of similar work in the last 10 (ten) years is at least equal to 50% (fifty percent) of the total value of the HPS/Budget Ceiling.
 - Work in the field of preparation of urban planning/ policy documents, environmental and social impact assessments, as well as feasibility study documents and Detailed Engineering Design (DED) in the fields of waste management, wastewater management, energy, transportation, and/or biodiversity;
 - Work with the scope of project implementation management and project development.

- f. Have human resources:
 - Experts experienced in drafting urban national policies and urban development planning with the Government;
 - Managerial personnel; and
 - Technical personnel (if needed).
- g. Have the ability to provide equipment (if needed)
- h. The consultant is responsible for the implementation of all activities as described in the Term of Reference (ToR) and must provide office space, facilities, staff, and equipment that will enable him to carry out tasks in a timely manner.

Key Experts will not be evaluated at the shortlisting stage.

Consultants may associate with other firms to enhance their qualifications, but should indicate clearly whether the association is in the form of a joint venture and/or a sub-consultancy. In the case of a joint venture, all the partners in the joint venture shall be jointly and severally liable for the entire contract, if selected.
