A. BACKGROUND

The phenomenon of urbanization is no longer perceived as a problem but rather a necessity. In 2021, the urbanization rate in Indonesia will reach 57% with an urbanization rate of 1.8% (UN – Dept of Economic of Social Affairs & World Bank, 2021). Population growth can encourage urbanization and the development of small and medium-sized cities throughout Indonesia, as well as large towns and peri-urban areas, forming mega-urban regions. However, without proper interventions in the form of environmental management strategies, this rapid urbanization can result in environmental degradation, loss of biodiversity, and a decline in the quality of settlements.

Funded through a grant from the Global Environment Facility (GEF), the Indonesia Sustainable Cities Impact Project (SCIP)¹ aims to promote integrated urban development planning from the national to city levels. The primary objective of this project is to support cities to mainstream environmental and climate change considerations in urban planning and development, prioritizing capital investment and preparing high-quality sub-projects, including financing schemes. At the national level, it will provide input for environmentally sound urban development planning. At the city level, it supports cities to develop area/corridor-based development and spatial plans that are appropriate, consider biodiversity, and are adaptive to climate change.

The GEF-SCIP consists of five main components: i) integrated spatial planning and urban management; ii) catalyzing integrated investment in priority areas; iii) piloting innovative financing approaches and instruments; iv) policy dialogue and knowledge management and v) project management. The Directorate of Spatial Planning, Land Affairs, and Disaster Management, Bappenas, serves as one of the Project Implementing Units (PIU) in **Component I**: Integrated **Spatial Planning and Urban Management**. This component focuses on three outputs, which include: i) procedures for integration and policy recommendations for the Strategic Environmental Assessment (KLHS) into the Spatial Planning (RTR); ii) review and recommendation on policies for coordinating the implementation of spatial planning ; and (iii) review and recommendation on policies for the provision and utilization of green open space (RTH).

For the implementation of the GEF-SCIP activities, 5 (five) pilot cities have been selected, namely Palembang, DKI Jakarta, Semarang, Balikpapan, and Bitung. These cities represent different typologies of urban areas in Indonesia, ensuring that the study results obtained can effectively reflect issues across various urban typologies. To support implementing these activities, the Directorate for Spatial Planning, Land Affairs, and Disaster Management is seeking an Individual Consultant – Urban Planning Specialist to support monitoring and analyzing data for the GEF-SCIP activities in Component I.

B. SCOPE OF WORK

Individual Consultant – Urban Planning Specialist will be placed in the Directorate of Spatial Planning, Land Affairs, and Disaster Management to provide support in monitoring, conducting data analysis, and communicating with internal and external parties regarding GEF-SCIP activities in Component I. He/ she shall perform the following tasks:

- 1. Compile activity documents and conduct data analysis relevant to spatial planning and integrated urban management as needed by the project;
- 2. Compile a brief theoretical study on issues related to Integrated Spatial Planning and Urban Management, within the component 1 scope of works;
- 3. Coordinate and supervise the implementation of GEF-SCIP activities under component 1 and provide recommendation to improve their effectivity and efficiency in achieving the project's objectives;
- 4. Review and provide input on the overall process of GEF-SCIP activities planning and implementation, including exploring for joint activities across components as relevance;
- 5. Oversee the progress of overall GEF-SCIP activities in terms of technical aspects/substance, and how it relates to Component 1 deliverables;
- 6. Engage in discussions with internal and external parties on technical aspects of project's implementation and its financial aspect as relevance to GEF-SCIP in component 1; and
- 7. Conduct field visits as necessary to gain overview of activities implementation.

The incoming Urban Planning Specialist will be responsible for following activities: i) preparation; ii) focus group discussions; iii) coordination with local government; iv) supervision activities; and v) preparation of reports.
